

NVTC Commends Virginia's Advancement of Operating Funds to Transit Agencies During Federal Shutdown

Arlington, VA – As the federal government shutdown continues, the Northern Virginia Transportation

Commission commends the Commonwealth of Virginia on its decision to advance state operating funds to transit agencies. "While our bus and rail systems have yet to suffer major impacts from the budget impasse, the Virginia Department of Rail and Public Transportation's proactive approach will help stave off potential consequences such as service reductions," said NVTC Chairman Matthew F.

Letourneau. "NVTC and its member transit agencies appreciate the advancement of state operating assistance given the uncertainty surrounding the reinstatement of federal payments."

A recent letter from DRPT to bus and rail providers noted that "the federal government budget impasse continues to impact administrative activities with the Federal Transit Administration (FTA). Specifically, draws of federal funds from the FTA have been halted. In an effort to ease the burden the federal government shutdown is having on your agency's cash flow, the Virginia Department of Rail and Public Transportation will process operating
