This summary table represents the final Round One (FY 2020-2021) application evaluations for Commuter Choice on the I-395/95 corridor.

Applications were evaluated based on the information documented in the submitted applications or in subsequent technical clarifications. The evaluation is consistent with the methodology established in the <u>I-395/95 Commuter Choice Program Project Selection Process</u> and adopted by the Commission (and PRTC) in April 2019.

Total technical merit (maximum of 100 points) is scaled to develop Technical Merit Score (maximum of 55 points).

Transit operating funding requests total \$5,629,002 (18 percent of all requested funds) and are defined based on FTA Circular 9030 (urbanized area formula grant program) and FTA Circular 9040 (rural area formula grant program) and includes fuel, oil, driver salaries and fringe benefits, and licenses.
