Ms. Mattice reviewed the Agenda for the March 5, 2020 NVTC meeting, which includes recognition of two departing Commissioners (Christian Dorsey and Dave LaRock), new appointments to the WMATA Board and NVTC WMATA Committee, state grant applications, contract award for Creative Services, Resolution of Endorsement for the Bus Transportation Project, NVTC Regional Fare Collection update, Commuter Choice update, legislative update, and the FY 2020 2nd Quarter Ridership and Parking Utilization Reports.

Ms. Mattice also reviewed the findings from the NVTC Market Research Study. She also talked about a Commuter Choice Marketing/TDM needs assessment and opportunities to do some targeted outreach with the NVTC jurisdictions.

The Executive Committee then discussed upcoming Commission activities, specifically focusing on the next few months from March to July. WMATA General Manager/CEO Paul Wiedefeld is expected to attend the April Commission meeting to discuss WMATA issues. NVTC staff continue

to focus on the Commuter Choice (I-66) Round Four program, prep for the Summer 2020 WMATA shutdown, WMATA oversight on policy issues and budget deliberations, Route 7 analysis, and fare payment technology upgrades. NVTC staff is also closely monitoring legislation coming out of the General Assembly Session.
