Chair Cristol called the Executive Committee meeting to order at 6:03 p.m. She explained that NVTC is back to in-person meetings, with a few modifications. NVTC is continuing with its safety protocols due to the surge in the Delta COVID variant. She noted three committee members who are participating electronically. Mr. Letourneau is participating electronically due to a medical reason. Mr. Smedberg and Mr. Snyder are participating electronically due to personal reasons.

Ms. Mattice confirmed an in-person quorum was present.

Chair Cristol noted that the summary of the May 6, 2021 Executive Committee meeting was provided and there were no corrections from committee members.

Ms. Mattice gave an overview of the Commission Look Ahead for the rest of the calendar year. The committee meeting materials provided a two-page outline of the remaining Commission meetings in 2021, including key milestones, anticipated actions and planned committee meetings. Some of the highlights include:

- Staff will be recommending a slate of projects for Commuter Choice on the I-66 Corridor and open the next call for projects in the corridor.
- NVTC's Transit Resource Center will be launching the next study phase and public engagement for Envision Route 7, the planned Bus Rapid Transit system connecting Tysons, Falls Church and Alexandria.
- NVTC will develop its legislative agenda outlining priorities at the state and federal level and host the annual Legislative Briefing for lawmakers.

- NVTC will publish the 2021 Annual Report on the Performance and Condition of WMATA with NVTC recommendations on ways to control costs.
- NVTC staff will take a deep look at key policy issues emerging in public transit publishing our zero-fare/reduced-fare white paper and hosting a symposium on zeroemissions buses.
- And, finally, the general and administrative budget will be presented to the Commission.

Ms. Mattice also noted that this fall is the time to be scoping out the future slate of officers and appointees for approval in January. NVTC currently has committee chairs for the WMATA Committee, Program Advisory Committee and Legislative and Policy Committee that can be reconfigured. Per the By-Laws, if Mr. Aguirre becomes NVTC's new chair, he cannot continue to chair the WMATA Committee, Mr. Alcorn would be the default chair of the NVTC WMATA Committee as he is the other eligible candidate as a Metro Board alternate. Mr. Smedberg would need reappointment from the Governor to continue to serve on NVTC and WMATA as his term expires in January. (That was always envisioned to align with the gubernatorial term.)

Ms. Mattice also discussed the WMATA Board appointments. NVTC would need to reaffirm the current principal and alternate directors in January. She reminded the committee that NVTC's 2018 policy imagined a rotation around the region to allow Fairfax County, Arlington, Alexandria and Loudoun to have one principal director appointed over a 12-year period. Per the Virginia Code, each director has a four-year term; this envisions some two-year appointments.

Ms. Mattice previewed the Agenda for the September 2 NVTC meeting, which follows this committee meeting. Ms. Mattice noted that no public comments were received prior to the meeting. She reviewed the action items on the Agenda including the minutes, Consent Agenda (Approval for the Executive Director to Sign Non-Disclosure Agreements on Behalf of NVTC, a Memorandum of Agreement Pertaining to NVTC General Counsel Services, and a Letter of Endorsement for the Transit Ridership Incentive Program), and four VRE actions (Amended Norfolk Southern Operating Access and Amtrak Access and Storage Agreements, Amended Agreements with the Virginia Passenger Rail Authority and with CSXT to include the Potomac Shores Station, Purchase Agreement and Memorandum of Understanding with the Department of the Navy, and Amended VRE Financial and Debt Management Principles).

Ms. Mattice gave on update on upcoming Commission meetings. The Program Advisory Committee is scheduled to meet in-person on September 13 at 4:00 p.m. and the NVTC WMATA Committee is scheduled to meet in-person on September 16 at 6:00 p.m. The Legislative and Policy Committee will be meeting prior to the October 7 Commission meeting, instead of the Executive Committee.

Chair Cristol adjourned the meeting at 6:38 p.m.
